

# THE ZUMIEZ STASH SWEEPSTAKES

## Official Rules

**Dates: 9/11/2015-10/13/2015**

**1. NO PURCHASE NECESSARY.** Sweepstakes begin at 12:01 a.m. 9/11/2015 and ends at 11:59 p.m. 10/13/2015. For purposes of these Official Rules, all times are Pacific Time ("PT").

**2. ELIGIBILITY.** Sweepstakes are open to legal residents of the 50 United States and the District of Columbia. Void in Puerto Rico and where prohibited or restricted by law. If the winner is under the age of 18, the winner's parent or legal guardian must give consent. Entrant must have internet as of 9/11/2015 in order to enter the Sweepstakes. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email address used to enter, if applicable, will be deemed to be the entrant.
